# **USFWS Update on Bear 927**

- Power point by Wayne Kasworm, USFWS
- Overview: 22 grizzlies augmented in the Cabinet Mountains within the Cabinet-Yaak
  Grizzly Bear Recovery Area since 1990 three of whom are known to have reproduced.
  Ongoing genetic sampling will help determine success of augmentation program by
  showing gene flow and effective linkages in Recovery Areas. 2-year old male grizzly 927
  was fitted with a radio collar and released in the Cabinet Mountains in 2018, but months
  later crossed the Clark Fork River and was captured at a black bear bait site. He was

returned to the Recovery Area, but traveled back to the bait site area before returning to the Recovery Area and denned for the winter within 5 miles of his initial release site. After emerging from his den he crossed Hwy 200 in April 2019, I-90 near DeBorgia in May, Hwy 12 near Lolo Pass in June, spent June-August in the Selway-Bitterroot Wilderness before beginning to return in mid-September, and is currently east of the Cabinet-Yaak Recovery Area. Other grizzlies in the augmentation program have also made journeys outside of the Recovery Area. The monitoring program emphasizes there is a direct relationship between where the grizzlies travel and places of sanitation concerns (i.e. garbage removal or disposal, food attractants, and black bear baiting sites).

# <u>Increased Information & Education (I&E)</u>

- Previous conversations identified the need for robust efforts and strategic I&E plans.
   Need a baseline I&E structure in the Bitterroot Valley between the county, NGOs, USFS, MT FWP, and partners to provide consistent public messaging and outreach while not duplicating efforts. Governor's Grizzly Bear Advisory Council agrees this is timely work which can help inform their efforts. I&E contacts: J.J. at ID F&G, Mike Pruss on the Nez-Clear National Forest, Kim Annis at MT FWP.
- I&E Working Group was formed last meeting off of the Ecosystems Subcommittee. Need to include Bitterroot Disposal. Jamie & Erin were identified as conveners for the working group, and will help identify additional participants.

#### ☑ Action Items

- Jamie, Erin, & Chuck: Send out email inviting potential I&E working group participants, including groups who have successfully worked on bear issues. Set winter meeting date Initial meeting is to brainstorm I&E ideas for consistent baseline efforts across entities.
- State and Federal Agencies: Need guidelines and clear expectations from agency leadership for committees, especially regarding bear baiting. Provide guidelines and expectations to I&E working group conveners and Chair.

#### Governor's Grizzly Bear Advisory Council (GBAC)

- Overview: The Council offers a public engagement forum to consider strategic objectives surrounding human influenced grizzly bear management challenges which will be provided to the Governor as long-term vision recommendations for bear management and conservation efforts in Montana. Recommendations from Council will be reported to the Governor's Office by August 2020. Staff from University of Montana's Center for Natural Resources & Environmental Policy program plan and facilitate meetings which are open to public and offer small discussion sessions for public participation. GBAC website has a public engagement and comment portal, and meeting summaries will be posted soon after approved by the Council. During meetings, an agency support team (MT FWP, US F&WS, USFS) is present to advise Council on law and policy. Previous meetings included a trial run of record the meeting for additional public engagement.
