
### **MEETING STRUCTURE?**

# **IGBC OVERARCHING GOALS (2019)**

- Understand relationships between emerging patterns in recreation and grizzly bear conservation to support effective measures in preventing conflicts and mortalities.
- 2. Identify landscape conditions that allow interchange and dispersal in areas between ecosystems and, where desired and feasible, maintain and enhance those conditions.
- **3.** Identify trends and concerns, and support effective preventative measures to reduce human-bear conflicts and human caused mortality.
- 4. Provide strategic support and direction to Bitterroot, Selkirk, Cabinet Yaak, and North Cascades Ecosystems for continued grizzly bear conservation and recovery efforts.
- **5.** Support and coordinate integrative approaches to increase effectiveness and accuracy of population monitoring.
- 6. Improve effective communication across all levels of IGBC
