- Understand relationships between emerging patterns in recreation and grizzly bear conservation to support effective measures in preventing conflicts and mortalities. [CONFLICT]
- Identify landscape conditions that allow interchange and dispersal in areas between ecosystems and, where desired and feasible, maintain and enhance those conditions. [HABITAT]
 - Identify trends and concerns, and support effective preventative measures to reduce human-bear conflicts and human caused mortality. [CONFLICT]

North Cascades Ecosystem Subcommittee
