Manufacturers of IGBC-certified bear-resistant products are required to verify that their products are still manufactured to original specifications. This process helps ensure that information provided to consumers is current and accurate.

Products from manufacturers that have completed this verification process appear on this list of IGBC-certified bear-resistant products.

Products that have not been confirmed appear on a separate list of certified products. Unconfirmed products are still considered certified by the IGBC, but the IGBC has not confirmed that products are made to the same specifications and are still available for purchase.

Manufacturers can contact the testing program at testing@igbconline.org, confirm the status of their IGBC-certified products, and have their products added back to the official IGBC list of certified bear-resistant products.

Introduction

Interagency Grizzly Bear Committee (IGBC) Certified Bear-Resistant Products provide a way to secure food, garbage, and other attractants on public and private lands. These products have been tested by the IGBC and meet or exceed IGBC's minimum standards.

Certified products are one method of complying with some food and garbage storage requirements on public lands. These requirements apply to most National Forests, National Parks, and federal lands managed by the Bureau of Land Management, and some state lands within grizzly bear range. Certain municipalities, private landowners, and homeowner's associations also implement garbage or attractant storage ordinances and by-laws requiring use of IGBC certified products.

The IGBC does NOT determine if bear-resistant products can be used to meet food or garbage storage regulations, or which types or brands of products can be used to meet regulations. Each land management authority (i.e., US Forest Service, Park Service, state wildlife agency or other entity) determines specific products and methods that can be used to comply with food storage regulations that apply on lands managed by that entity.

Please ensure you are choosing or using a product that complies with the requirements that apply in the area you will be visiting.

The IGBC List of Certified Products includes two groups of bear-resistant products and designs.

- Bear-resistant products that are confirmed as being manufactured to the specifications the IGBC certified and are available for purchase. Links provided with these products connect to the manufacturer's homepage or other websites (when possible) where the product can be purchased.
- Electric fence designs and products that meet IGBC standards for securing attractants in areas where grizzly bears may be present. *

* Electric fence designs and products listed in this document are not intended to replace general bear safety guidelines for preventing bears from being attracted to tents and/or areas while people are sleeping.

Products in this document have been tested by the IGBC and have met IGBC standards as grizzly bear-resistant. Certification does not guarantee that a grizzly bear will never gain entry to these products. Nor does the IGBC guarantee that small amounts of the contents of the containers won't be able to leak or spill out.

ELECTRIC FENCING TO DETER GRIZZLY BEARS

The IGBC recommends several electric fence designs that have been proven effective in deterring grizzlies and are an option for securing bear attractants in areas frequented by grizzly bears. The first design is intended for longer term applications including securing livestock, fruit trees, compost piles, chicken coops and other attractants on private lands, as well as securing outfitter camps on both public and private lands.

The second design describes components of portable electric fences that can be used when recreating in bear country to secure attractants and campsites, or whenever a temporary means of securing bear attractants is needed. Please consult with the land management authority for the area you plan to recreate in for information about specific food storage requirements in that area.

A Note About Proper Use of Electric Fences:

Common reasons for electric fence failures include failing to turn the fence on at night, improperly grounding the fence, inadequately clearing weeds, shrubs or trees shorting out fences, and failing to fully charge batteries. Protecting energizers from excessive jarring and moisture will also minimize chances of energizer malfunction (i.e. broken internal wiring or on/off switches) and the resulting electric fence failure. To ensure that fences are working properly, test the amount of voltage flowing through the fence using one of the economical and lightweight voltage testers that are now available.

Permanent or Semi-Permanent Fence Designs

The seven strand electric fence has applicability in situations such as permitted base outfitter camps, or around beehives, orchards or chicken coops on private land where the fence is typically in place for a longer period of time.

Portable Electric Fence Designs

Portable electric fences are an effective method of temporary food storage in grizzly bear country. Table 2 summarizes the minimum specifications necessary to deter grizzlies. These specifications may be updated as additional testing of portable electric fences are tested in areas frequented by grizzlies.
